The Master Painters "Project of the Year" will be selected from one of the above categories winners.

OUTLINE OF AWARDS FORMAT AND JUDGING

The awards are administered by the Master Painters Association. A panel of judges is chosen each year. The project is judged on the following criteria depending on which category a project has been entered in:

- Preparation
- Regular & blemish free surfaces
- Degree of application marks
- Uniformity of colour & opacity
- Cleanliness of fittings & fixtures
- Evenness of finish
- Artistic skill and technical capability
- Cutting in between finishes and surfaces
- Degree of difficulty
- Overall effect and visual appeal

CONDITIONS OF ENTRY

1. The competition is open to licensed contractors in domestic work and all contractors in commercial and industrial works in NSW and ACT.
2. The Award competition is open to both non-members and members of Master Painters Australia.
3. Contractors may nominate their own project or projects may be nominated by third parties such as project owners or suppliers of painting and decorating materials or services.
4. Only projects completed within the period January 1st 2009 to May 30th 2010 may be entered.
5. Entrants must provide at least 3 colour photographs of their project to enable the judging panel to determine whether the entry warrants on-site inspection. If photos are not supplied, the project will **not** be inspected. **(Digital photographs are essential.) Photographs can not be returned.**
6. Finalists may be asked to provide further photographs, suitable for publication.
7. Not all projects will be physically inspected. Selection of projects for inspection is at the judges discretion. Projects selected for inspection will be visited by a member or members of the judging panel.
8. Judging procedures and decisions will be entirely at the judges discretion and **no correspondence will be entered into.**
9. Entrants should ensure that the project owner's permission is given for the project to be inspected by the judges, with additional permission to be sought from the owners of Award-winning projects for publication and publicity.

The Award presentation will be made at a Gala Dinner to be held in August 2010
